**ASSUMPTION OF RISK, RELEASE AND
WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

Please read this form carefully and be aware that in registering your minor child (hereinafter referred to as "Participant") for participation in the 2014 Louisiana Governor's Games Soccer Tournament (hereinafter referred to as "Tournament"), you will be waiving and releasing all claims for injuries you or Participant might sustain out of the Tournament. In consideration for permitting Participant to participate in the Tournament, on behalf of yourself, your respective heirs, personal representatives, assigns and Participant, you agree as follows:

Assumption of Risk: The undersigned hereby acknowledges and agrees and understands the nature of the Tournament; that Participant is qualified, in good health, and in proper physical condition to participate therein; that there are certain inherent risks and dangers associated with the Tournament; and that, except as expressly set forth herein, you knowingly and voluntarily, accept, and assume responsibility for, each of these risks and dangers, and all other risks and dangers that could arise out of, or occur during, Participant's participation in the Tournament.

Release and Waiver: The undersigned hereby **RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE** the Young Leadership Council, Inc., New Orleans Recreation Development Commission, New Orleans Recreation Development Foundation, City of New Orleans and/or

any subdivision thereof, the Governor’s Council on Physical Fitness and Sport, Tulane Institute of Sports Medicine, and each of them, their officers, employees, volunteers and/or agents (collectively, the “Releasees”), from and for any liability resulting from any personal injury, accident or illness (including death), and/or property loss, however caused, arising from, or in any way related to, Participant’s participation in the Tournament.

Indemnification and Hold Harmless: The undersigned also hereby agree to **INDEMNIFY, DEFEND AND HOLD** the Releasees **HARMLESS** from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities including, but not limited to, attorney’s fees, arising from, or in any way related to, Participant’s participation in the Tournament.

Permission to Use Likeness/Name: The undersigned further agree to allow, without compensation, Participant’s likeness and/or name to appear, and to otherwise be used, in material, regardless of media form, promoting the Young Leadership Council, New Orleans Recreation Development Commission, New Orleans Recreation Development Foundation, City of New Orleans, and/or their events and activities, including those of its representatives and licensees.

Severability: The undersigned expressly agree that the foregoing assumption of risk, release and waiver of liability and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Louisiana and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: The undersigned has read this Assumption of Risk, Release and Waiver of Liability and Indemnity Agreement and fully understands that the undersigned is giving up substantial rights in connection herewith, and that its terms are contractual, and not a mere recital. The undersigned acknowledges that he or she is signing this agreement freely and voluntarily.
